The real life legal issues of Ephraim, Priest of the order of Melchizedek -
status 29.3.2017, Baptism name ULF DIEBEL *25.5.1967

- Working Document

This German surname of DIEBEL was a baptismal name meaning 'the descendant of Theobald'. The name was originally derived from the Old French TEOBAUD, and brought into England in the wake of the Norman Conquest of 1066. Early records of the name mention TEOBALD (without surname) listed as a tenant in the Domesday Book of 1086.

Theobald V. was the last King from Europe who took care of the Kingdom of Jerusalem 1241.

History gives us a good account, that the normans were of the tribe of Benjamin known as fierce fighters within the family of Israel. The Galileans of the time of Jesus were of Benjamin, like the apostle Paul, who settled the Northern part of Israel, when Judah came back under Ezra and Nehemiah to rebuild the Temple. After the 1st and 2nd Jewish revolt, our ancestors left Israel into all corners of the Roman Empire, to meet up with the other family members, who already came 500 years earlier.

Over the centuries, the descendants of Theobald (meaning strong man) were in a constant conflict with Rome and after the crowning of Karl as emperor of the Holy Roman Empire of German Nations on 25.12.800 they had their constant quarrels with the Papacy.

Within the territory of that renewed Roman Empire, the semitic tribes from Edom and Jakob concentrated and were in constant fight against each other over the "true faith" and the kingship in the family.

Up until the great investiture conflict in the 11th and 12th century, the royal families of Europe chose the Pope as the highest official of the church from within their own ranks.

The firstborn and heir of the throne was educated as King, while the royal siblings often chose a position and education in the church to guide the family in spiritual, moral and ethical questions. After the investiture conflict, the Papacy created an extra body of cardinals and started to elect the Pope from within their own ranks and gained control of the political structure of Europe with the power to crown and displace Kings and Royals.

By the time of the reformation, the descendants of Theobald joined the new faith of Luther to flee the suppression of Rome, who countered the reformation with the foundation of the Jesuits.

One part of the family moved to Hessen, from where my Grandfather Hans Heiner Jakob Diebel originates. Due to the turmoil of the last two world wars, the family can only be traced to a certain point, but one thing is sure.

We represent the fullness of all the problems, which came over the people from Germany in the last 110 years. And only now, 70 years after the end of the Holocaust, the fullness of the problems can be named and proper action taken.

The history of the last 110 years can be traced seemless, as well as the overall development of the laws of governments who reign currently over the Diebel family.

Since 1994 Ulf and his family tried to live a life according to the Bible in the faith of Abraham, Isaac and Jakob in Jerusalem. By the end of 2007 the family received “Tudat Seut” - Israeli ID's.

On 01.01.2008 the family was rejected at the US border and a series of events lead to an amount of legal issues in connection with our rights in Jerusalem. Since that day we are in Germany and became subject to the highest form of discrimination in Germany, leading to a separation of our family.

On 01.01.2015 a call from Jerusalem triggered a true reawakening in strength to solve the massive problems laid before us.

After months of consultation and planning “Ephraim - Society for the advancements of the social and working conditions of Israelite priests after the order of Melchizedek” was declared on 25.5.2015 according to GG § 4,9 and 140 to give the challenging legal issues a true biblical Face.

For 21 years Ulf and his family tried to live according to the Laws of Torah, which became impossible in a Roman Law system, violently opposing the truth of the Word of God for hundreds of years.

With the declaration of Ephraim, Ulf Diebel acts as the Firstborn Son of God (Jeremiah 31.9) , with the goal to bring an end to all discussions about the Torah and Jesus Christ between Jews and Christians and to bring the true Heavenly Kingdom back to Israel, as proclaimed by the Word of God.

Not by might, nor by power, but by the spirit of God.

Per 30.06.2015 the status of the BRD is different than the borders and legal structure of the German Reich. The German Government, after a request of the Left party "Die Linke" declared, that the German Reich exists, but that it has no organs (no legal representation) to act. All functions of the still existing German Reich are taken over by the BRD GmbH (Limited) until the day, that the German people declare a new Constitution (GG Art. 146)

Whoever will take a look at my full CV, will see that this situation is quite unusual and absolutely not normal for a business guy, who is trained to deal with unusual situation in any country. Anywhere outside Germany I am successful in the shortest period of time. Inside Germany I am cursed and excluded from society, because I stand with Israel and the Jewish people and live like Jesus according to the Law of Moses.

For none of the injustice done against myself and the whole family, I never went to court or sought a legal confrontation, because I always believed and will believe in the true final judgement of God Almighty and the possibility of repentance of any sinner, while he is alive.

The whole point of our existence is to forgive his brother and help him after a great catastrophe in his life. While the laws of Torah explicit requires a Jubilee Yom Kippur in Jerusalem for the forgiveness of all wrongdoings, that the people may live free, the laws of Rome are unforgiving and financial debt is taken over from generation to generation, as it is today. Since 1949 any German born is by law guilty of crimes he did not commit and enslaved to a system of laws, hundreds of years old.

While it might take a while to communicate the holy task of Ephraim, it needs to be understood, that Ephraim is a private endeavour and acts in the interest of the Nation of Ephraim in the form of business.

The enemies of Ephraim, Judah and the people of Israel are the spiritual strongholds of greek philosophy and roman law against the Holy Spirit of Torah.

70 years after the creation of the UN and 50 years after the birth of modern day Jerusalem, I believe that the world waits for the transfer from the latin law of Rome to the Torah from Zion. But it pleased my Father in Heaven, to bring me to the lowest place possible, that the words of the prophets might be true, that I cannot lift myself up, but by divine intervention, he can move the hearts of the kings and show, that he can elect the lowliest of people in the year 2017, like it says in Daniel 4.17

‘The decision is announced by messengers, the holy ones declare the verdict, so that the living may know that the Most High is sovereign over all kingdoms on earth and gives them to anyone he wishes and sets over them the lowliest of people.’

Anderen Religionsgesellschaften sind auf ihren Antrag gleiche Rechte zu gewähren, wenn sie durch ihre Verfassung und die Zahl ihrer Mitglieder die Gewähr der Dauer bieten. Schließen sich mehrere derartige öffentlich-rechtliche Religionsgesellschaften zu einem Verband zusammen, so ist auch dieser Verband eine öffentlich-rechtliche Körperschaft.

(6) Die Religionsgesellschaften, welche Körperschaften des öffentlichen Rechtes sind, sind berechtigt, auf Grund der bürgerlichen Steuerlisten nach Maßgabe der landesrechtlichen Bestimmungen Steuern zu erheben.

(7) Den Religionsgesellschaften werden die Vereinigungen gleichgestellt, die sich die gemeinschaftliche Pflege einer Weltanschauung zur Aufgabe machen.

(8) Soweit die Durchführung dieser Bestimmungen eine weitere Regelung erfordert, liegt diese der Landesgesetzgebung ob.

Art. 138

(1) Die auf Gesetz, Vertrag oder besonderen Rechtstiteln beruhenden Staatsleistungen an die Religionsgesellschaften werden durch die Landesgesetzgebung abgelöst. Die Grundsätze hierfür stellt das Reich auf.

Anmerkung: Nachzahlung für entgangene Leistungen seit 20.02.1907

(2) Das Eigentum und andere Rechte der Religionsgesellschaften und religiösen Vereine an ihren für Kultus-, Unterrichts- und Wohltätigkeitszwecke bestimmten Anstalten, Stiftungen und sonstigen Vermögen werden gewährleistet.

Art. 139

Der Sonntag und die staatlich anerkannten Feiertage bleiben als Tage der Arbeitsruhe und der seelischen Erhebung gesetzlich geschützt.

Anmerkung: Transfer des falschen Feiertages von Sonntag auf Samstag - nationaler Shabbat.
Zeitmessung von Jerusalem aus.

Art. 141

Soweit das Bedürfnis nach Gottesdienst und Seelsorge im Heer, in Krankenhäusern, Strafanstalten oder sonstigen öffentlichen Anstalten besteht, sind die Religionsgesellschaften zur Vornahme religiöser Handlungen zuzulassen, wobei jeder Zwang fernzuhalten ist.
