## Urgent Request for Presidential Help

Shalom David Melech,

Attached you find the letter to the former office holder of the US Embassy in Berlin, Kent Logsdon and the Israeli Ambassador in Berlin Jeremy Issacharoff, I sent 12.4.2018, as well as a private email I sent to my partner Michael Jay Solomon on 25.4.2018.

Attached is also the IRS Form of the International Christian Embassy in Washington, where Donald Trump made a sign up during pre-election with my friend Susan Michael and the letter I sent to chief justice Miriam Naor of the Israeli High Court of Justice from 23.8.2017 - sent via registered mail on my 21st wedding anniversary on 24.8.2017, naming Dr. Jürgen Bühler, who is a German citizen and receives regularly funds from the ICEJ Office in Washington.

As you can see in the correspondence, Dr. Jürgen Bühler called 1.1.2015, since my 48. Birthday Shavuot/Pentecost 25.5.2015, I am fully conscious about being Zachariah 9.9-13 Ephraim and received the file # 276 Js of the state prosecutor on 14.6.2018 - 77 days after my filing on 29.3.2018

From 1.1.2015 to the 72nd Birthday of Donald Trump 14.6.2018 are the 1260 days of Revelation mentioned in Chapter 11 & 12.

Only with the release of the Religious Freedom Report by Mike Pompeo on 29.5.2018, I learned about the Religious Freedom Act from 27.01.1998 and was thrilled to read, that it is US foreign policy to advocate on behalf of individuals, persecuted for their religious belief, practice and observance.

I am that ONE Jakob, HaShem called out to be his servant you read in Isaiah 49.1-7 and Isaiah 53 about and desperately need help, as I am just a „normal“ guy and as you can read in Daniel 4.14 - currently the least of all people.

When on 9 Av Dvarim started, the Haftara ends with Isaiah 1.27 - Zion will be redeemed through the Torah and those who return with justice.

In Isaiah 1.8 Yael Eden, the daughter of Zion is mentioned and in Isaiah 1.10 the situation in Berlin Sodom and Jerusalem Gomorra prominently described to the day.

Already on 16.7.2018, I filed a complaint with the state prosecutor Jörg Raupach about the Case 276 Js 773/18 with the Generalstaatsanwaltschaft Berlin Moabit concerning the criminal activities of a German in a foreign Country §5 StGB - namely Dr. Jürgen Bühler, president of the International Christian Embassy in Jerusalem, who has been visited over the last 4 years by Ronald Lauder (Email from 27.2.2018 attached), Benjamin Netanyahu and Reuven Rivlin.

It is as Isaiah 49.1-7 describes. After 7 years of desolation in my life, starting with the rejection to enter into the USA on 31.12.2007, I surely did not expect to be the light to the nations and horror befell me (Daniel 10 happened on 24.1.2015), I fully understand now.

As the expected „Son of God“, I had to do some crazy stuff in faith and had to demand the impossible as a seemingly penniless nobody.

World politics became as ridiculous as it can get and clearly nobody is able to talk to Donald Trump at this stage, when 128 nations including Germany voted against the US decision to move the US Embassy 50 m from the birthplace of Yael Eden, the Key of David (Isaiah 22.22 & Rev. 3.7)

Due to the unusual situation (nobody believes in a human messiah, except a handful of devote Jews and the assembly gathering at the western wall at the end of the 9 Av remembrance) the most easy and cheapest solution for all parties would be:

- 1.) Joint meeting between Michael Jay Solomon, Ronald Lauder, Dr. Jürgen Bühler, John Hagee, myself and President Donald Trump for the sake of Zion. (Isaiah 1.1-27)
- 2.) Official Recognition as Ephraim (Jeremia 31.9), Son of Josef (Micah 5.1) by Pope Francis and transfer of his power to me.
- 3.) Payment of 10% from all registered world-wide church members to Zion for the building of the Temple and New Jerusalem, starting from Mount Zion.
- 4.) Transfer of all the property held by the Church in Israel and especially Jerusalem to the rightful heir.

The US Intelligence service has all the ways and means to find out the truth, which is... there is no conspiracy at all (Isaiah 8), just a bunch of godless Hippies (Ronald Lauder calls them JINO's), who forgot to be sons of Jakob and got lost in fleshly lust and some over zealous Christian preacher, who collected money in the name of Jesus Christ into their own pockets (Maleachi 3)

In theory a secret service team could pick us all up and by the end of the ministerial conference 26.7.2018 in Washington, the question of all questions could be solved to the fullest satisfaction for the USA, President Trump, the Jewish People and the Church.

## Concerning Ephraim & US Embassy opening 14.5.2018

Shalom Mr. Ambassador Issacharoff,

Since 25.5.2015 I openly work under my new name and work description "Ephraim, Priest of the Order of Melchizedek" under the protection of GG Art. 4, 9 & 140, to secure my unique Human Right, guaranteed by the Holy See and the State of Israel in the adoption of UN Resolution 217 since signing the Fundamental Agreement between the two parties on 30.12.1993

On 29.3.2018 I handed the attached list to state prosecutor Hahn from the „Generalstaatsanwaltschaft Berlin-Moabit“ with a request of immediate involvement of the US State Department, due to the personal involvement of high ranking government officials from Israel, Germany and Israel in my „regular“ family case.

Since 5.3.2018 an open letter to the President of the International Christian Embassy Dr. Jürgen Bühler is asking for his resignation and hand-over of the ICEJ in Jerusalem.

Before I started out publicly, I told my Rabbi Avraham Feld in Jerusalem, what I will do and confirmed in writing, that I agree fully to the Authority of the Orthodox Jewish Leadership and the Jurisdiction of the Israeli High Court of Justice, but so far didn't receive any help or answer.

I am in Berlin right now and would like to give a full account of my work as a private citizen and clear up my legal paper work with the State of Israel. Besides the world-wide political, theological and financial implication, my intelligence is vital for the security of the State of Israel, as well as for Germany and the USA, I wrote the US Embassy Kent Logsdon.

On my last try to enter Israel to clear up my personal stuff, I was held in prison for a night on 2.9.2015 and sent back to Germany with extremely devastating results for my business, family and social standing.

Could I have a short-term appointment with you at the Israeli Embassy in Berlin and fix my paper work?

Shalom Michael,

When we met in Berlin, I came to you as a friend and private citizen, because I was hoping you were able to grasp, what I told you over the last 3 years. Unfortunately you didn't and as I hinted in our conversation, if nobody will react, I will go to court.

After sending you a presentation on 26.3.2018 with copy to the World Jewish Congress, I had to do my thing. In my books, I count \$1,65bn in damage for me and my shareholders, including you and I am fully set to create a multiple amount of wealth for all involved parties, by fixing some legal paperwork and a new deal between us.

On 29.3.2018 I gave three years of research and documentation to the state prosecutor in Berlin-Moabit and it is imperative, that you carefully read this letter and fully understand, what your personal involvement is. Besides the legal issues in connection with DreamStream, my wife wants to have a divorce and I am forced to do the dirty laundry, I really wanted to avoid for 3 full years.

My first Jewish friend Eliyahu Ben Haim, originally from New York, I met January 3rd 1996 (not married back then). On 21.11.2004 my daughter Yael Eden was born in my house on Kfar Etzion 6/9, right next to the Ben Haim's residence. Eliyahu became the godfather of Yael and still lives there.

The US Embassy in Jerusalem will open on 14.5.2018 - 50m from the birthplace of Yael Eden and my old address.

When on 14.5.2018 the State of Israel celebrates the 70. Anniversary according to the secular date, 25567 days since 14.5.1948 have passed. 25.5.67 is my birthdate, marked by the Pope as the "Eucharisticum Mysterium".

The law regulates the adoration of "Jesus" in the Eucharist "until he comes". The 21.11.2004 is by the law Lumen Gentium from 21.11.1964, the predetermined age of 37 years and 6 Months of the "Mystery", taken from 2. Samuel 5.5 age of King David, when he came king over all of Israel in Jerusalem for 33 years, until his son Solomon took over.

Yael Eden is what the Bible calls the "Key of David", written in Isaiah 22.22 and Revelation 3.7.

The "Key of David" (my kids), will unlock "the kingdom of heaven" and bring back the kingdom of Israel out of the hands of Pope Francis to Jerusalem.

In the insignia of the Pope you will find two keys. They are the key to "the kingdom of heaven", given to the person, who fulfills as a human all legal requirements by the Torah and the Prophets of Israel, as well as all requirements of the Church of Rome, to be the "King of Kings and Lord of Lord" mentioned in Revelation 19.

Regardless of what you will do, regardless how big your own agenda might be, you are part of my story and own Jerusalem agenda and I would lie, if I would say I am sorry for that, but you are not getting out of this.



Next to the documents I sent to the state prosecutor, I requested by letter appointments at the Israeli Ambassador and the US representative (Trump doesn't have an accredited ambassador in Berlin) to fix my personal paperwork, that I am able to be in Jerusalem at the opening of the US Embassy and meet Trump and Netanyahu.

Today 25.4.2018 is Berlin Kippa Day, after another Antisemitic attack against a Kippa wearing person made headline and my letter to the Chairman of the Central Jewish Council in Germany went public.

As my friend, Partner and Chairman of the Board of directors of DreamStream, I told you at all time the truth and protecting our interest, hasn't been easy, as they collide at several points due to our different backgrounds.

Please call your friend David Harris to prepare Deidre Berger in Berlin for a meeting with me ASAP, before I drive off to Israel, with a stop over in Belgrade with our DreamStream technicians.

Let me take over the dealing with the Truli content partner, and let me take care of the Evangelicals in the US, starting with John Hagee and his Christians United For Israel with 4 Million members, who should make the same 100 Euro sign up, like anybody else, who wants to make a new deal with me.

For the same 100 Euro New Deal between us, think about the value of the licensing rights of "Jesus Christ", who came back out of the grave... instead.. it's not Jesus, it is, as I showed you in Berlin, just me.

As you are Michael and I told you, that the Prophet Daniel talks about us, in the whole chapter 10 - 12, it might be that you receive phone calls from people, who received the same disclosure of Daniel 10 - 12, as you and Ronald Lauder did on 26.2.2018

Also.. you are a liberal Jew, Democrat and US Citizen, which is the complete opposite of me, but I think I turned out alright with 50.

As you know all the other "Christians" and whatnot, I think I am the most awesome German around and the best guy, you can ever get, as an advocate for the Jewish People to fight Antisemitism, I myself experienced now for 10 years here in Germany and cost me everything.

The God of the Jews sent the right guy... trust me.

I will give you a call tomorrow and see how you cope.

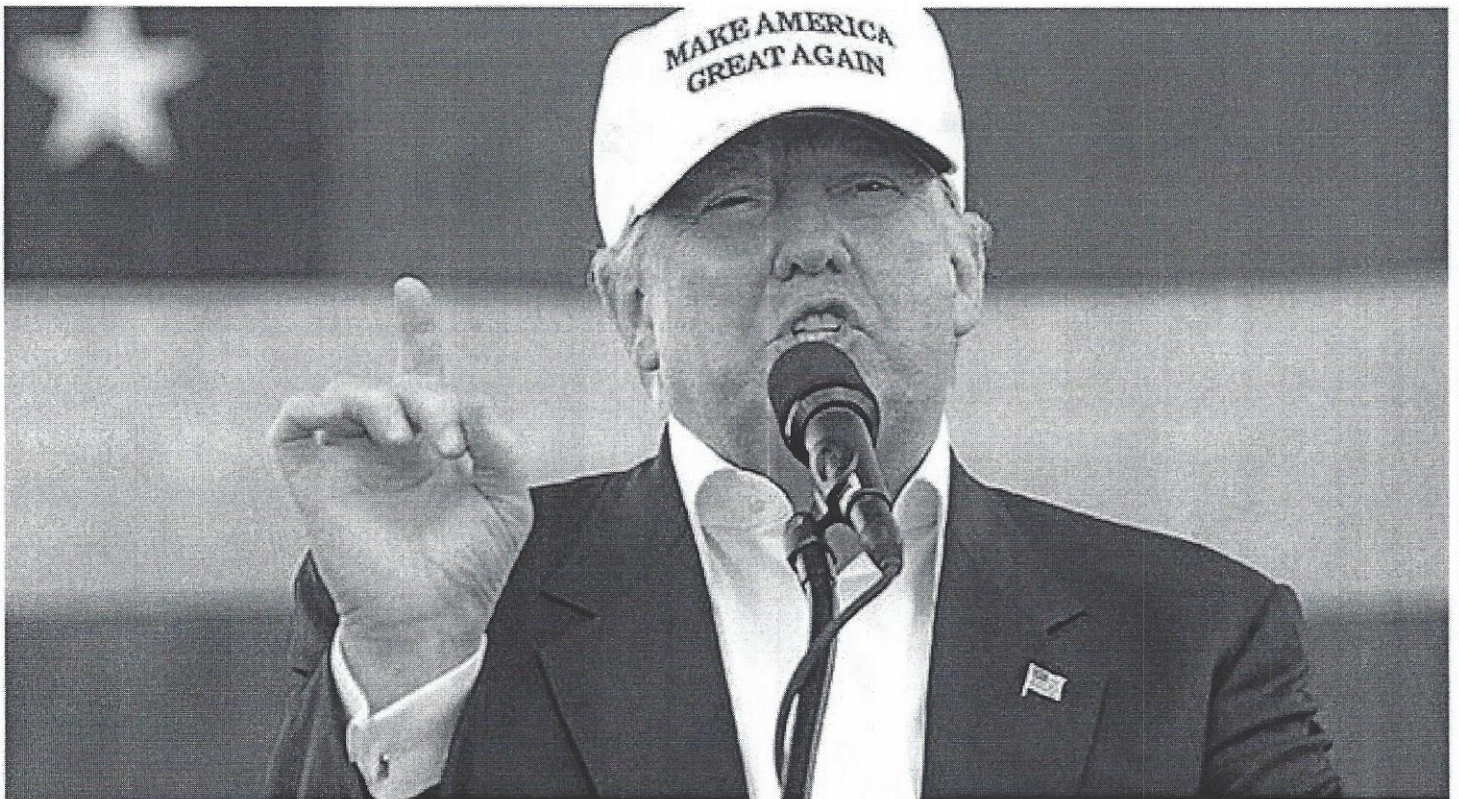

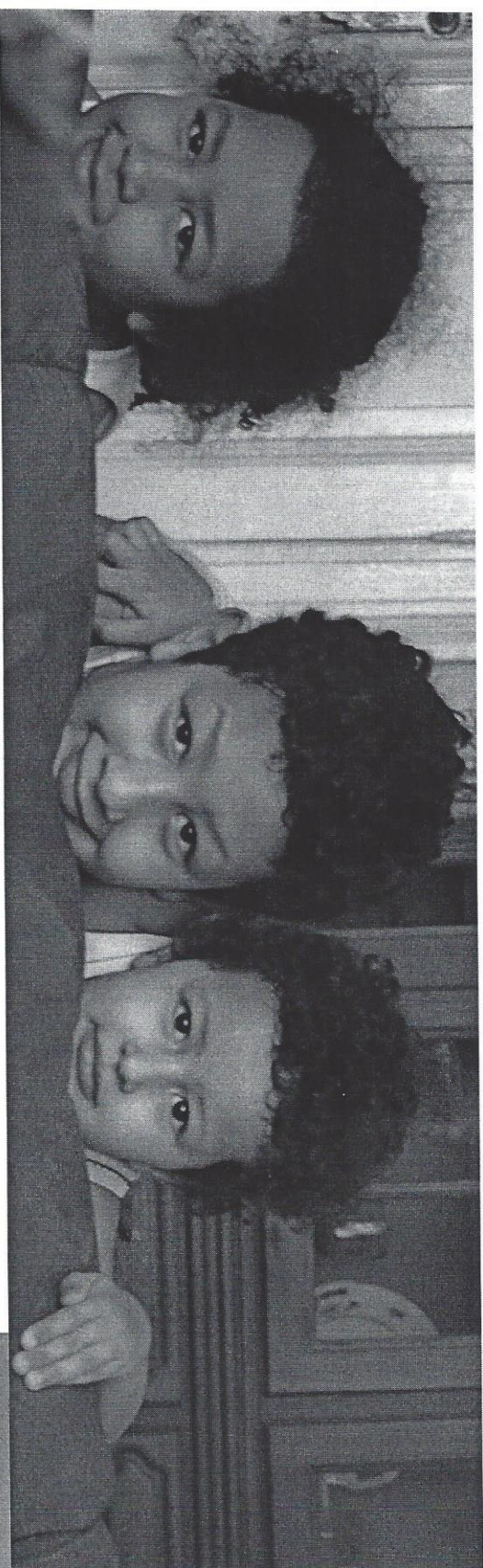

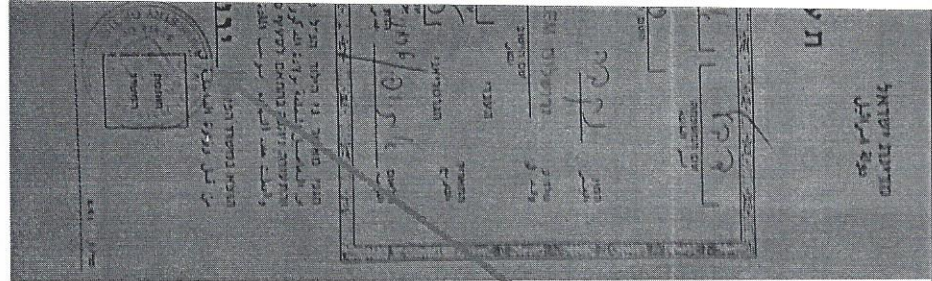

### Begründung:

Am 1.1.2015 wurde mir durch den Anruf des Präsidenten der Internationalen Christlichen Botschaft in Jerusalem, Dr. Jürgen Bühler der Straftatbestand eines Deutschen im Ausland mit Inlandsbezug nach §5 StGB bekannt, der mir durch ein persönliches Familiendrama beginnend mit dem 1.1.2008 über Jahre verborgen blieb und meine Firma „Israel Monthly U.D. Publishing 1998 Ltd“ in Jerusalem und meine US Amerikanische Firma DreamStream LLC betrifft, sowie meine Internationaler Markenname „Ephraim“. Seit September 2016 ist Donald Trump persönlich in den Fall involviert, wobei die Dokumente in den Beweisordnern liegen.

Am 25.5.2015 hatte ich sämtliche Geschäfte niedergelegt, um als ein nach GG Art. 4, 9 & 140 geregelten und geschützten Beruf auszuüben. Jedem Beweis Ordner ist ein unterschriebenes Deckblatt beigefügt, wobei der schwarze Ordner ausschließlich die Gesetze enthält, an die sich die Justizbeschäftigte Staatsanwältin Fischbach Obst hätte orientieren müssen.

Als ich am 29.3.2018 bei Staatsanwalt Hahn zusammen mit drei Zeugen erschien, machte ich explizit auf die außergewöhnliche Situation und den Zusammenhang mit den USA und Israel Aufmerksam und brachte unmissverständlich zum Ausdruck, dass wir ZWINGEND mit einem Staatsanwalt reden müssen, worauf uns Staatsanwalt Hahn versicherte, dass sich ein Dezernent bis spätestens am folgenden Mittwoch meldet.

Für volle 77 Tage war es unmöglich eine Antwort von der Staatsanwaltschaft zu bekommen, bis wir am 14.6.2018 das Aktenzeichen erhielten.



Aufgrund der Verbindung mit Jerusalem und der Straftaten des Deutschen Dr. Jürgen Bühler, wurde explizit nach einer Beteiligung des US-State Department und der Israelischen Botschaft verlangt - von Beleidigungen meiner Mutter ist in meiner Liste der von mir beklagten Personen nichts zu lesen, sondern von rechtswidrigen Maßnahmen meiner eigenen Frau und Mutter in Verbindung mit Dr. Jürgen Bühler gegen meine Person, die einen monetären Schaden von \$1,65 Milliarden verursacht haben.

Da die Staatsanwaltschaft nicht reagiert hatte, habe ich am 14.4.2018 selbst einen Brief an den Amtsträger der USA Botschaft und den Botschafter Israels Jeremy Issacharof mit Bitte um Klärung verschickt.

Ich bitte um einen Termin bei der höchsten Staatsanwaltlichen Autorität, um meine Zeugenaussage abgeben zu können, die zum heutigen Tag zwingend auch vor einem Vertreter der US und Israelischen Regierung gemacht werden muss, die eine Kopie dieses Schreibens zugeschickt bekommen.

**Antrag auf Klärung der Rechtmäßigkeit des Bescheids der Justizbeschäftigten Fischbach-Obst**

„Eine Straftat liegt nur vor, wenn der Gesetzgeber ein Verhalten genau beschreibt.... Dies ist erkennbar nicht der Fall. *Ein Verstoß gegen andere Gesetze, selbst gegen das Grundgesetz ist hingegen nicht strafbar.*“

Nach DSGVO, die zu meinem 51. Geburtstag am 25.5.2018 in Kraft getreten ist, wird der Verstoß gegen die unsachgemäße Verwendung von Personenbezogenen Daten mit bis zu 20 Millionen Euro pro Fall geahndet. Ich beantrage festzustellen, ob die Verfälschung meiner Anklage von Vertragsbruch & „rechtswidrige Maßnahme gegen GG Art. 9 Senait Diebel“ und „Jürgen Bühler, ICEJ in Jerusalem“ auf „Renate Diebel wegen Beleidigung“ der Justizbeschäftigten Fischbach - Obst ohne vorherige Rücksprache mit mir überhaupt Rechtsgültig ist.

Sollte die Aussage „Der Verstoß gegen Gesetze ist nicht strafbar“ wieder erwarten Rechtens sein, bitte ich um eine klare Aussage von Ihnen als Oberstaatsanwalt, welche Daseinsberechtigung die Justiz in Berlin hat und wer dann bei Ihnen für Korruption in der Justiz und Regierung verantwortlich wäre.
