Remembrance Day 24.4.17 I received by divine appointment the EPHI-Zentrum in Iserlohn on the 147th anniversary of the dogmatic constitution of the church DEI FILIUS from 24.4.1870.

Up to the last moment I hoped, that ONE family member, my wife, own mother, my business partners, or any of the „congregation“, a rabbi, pastor, business guy would react, but No.

HaShem has supernaturally blinded everybody and my normal family case - „Guy trouble with his wife, who wants a divorce“ turned into „I will wait for the Lord, who is hiding his face from the descendants of Jakob“ Isaiah 8.17

For quite some time, I knew that someone from the House of Rothschild must have the firstborn right of Judah, as written in Hesekeil 37.15, as the High Court of Israel carries your family name, where ONE single stone on a ladder is prominently displayed in the Courtyard of the building with my birthdate 25.5.67 built into the structure - THANK YOU! I filed for prosecution at the state prosecutor Berlin-Moabit on 29.3.2018 (also against the City of Iserlohn) and received the File Number 77 days later on 14.6.2018 with a rejection and another file number, after I sent the first letter to David Friedman.
